National Slavery & Human Trafficking Prevention Month

In January, the Nebraska Coalition turned its attention to National Slavery and Human Trafficking Month. Here are some highlights:

Slavery and Human Trafficking

- ▶ \$99 Billion
Made per year in sex trafficking
- ▶ 4.5 Million
victims of forced sexual exploitation
- ▶ \$51 Billion
made from forced labor
- ▶ 21 Million
victims of forced labor

The Nebraska Coalition has always had a vested interest in advocating policy at the state level in an effort to codify change into law.

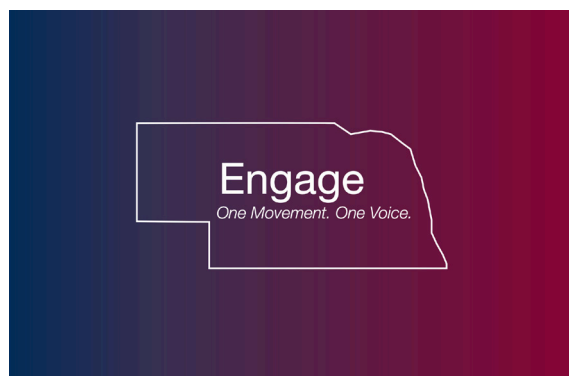


This work allows us to support those who have experienced violence, and work to root out the systemic causes of violence.

Nebraska Engage



Over the past year, the Nebraska Coalition has moved to create a comprehensive youth outreach program.

Titled Nebraska Engage, the purpose of this initiative is to connect with young people across the state.

Our core focus is to provide relevant training to produce young leaders who can extend this fight for generations to come.

We focus on advocacy and allyship, direct policy action, and how to engage in this movement using outcome-driven strategies. Last year, we launched two sub-programs to begin building this network.

Votes and Voices: The purpose of this initiative was to educate our member-network on how to engage young people in the civic process. In the 2020 election cycle, we executed a voter education campaign, a voter registration drive, and voter excitement campaign.

In the coming months, we will be using Votes and Voices to engage in the Lincoln Municipal Election cycle.

Young Leaders Coalition: This program serves as a leadership development program that has brought together high school and college students from across Nebraska.

Participants meet bi-monthly to hear from community leaders on a variety of civic and social justice issues. Beginning in September and running through May, students are tasked with creating a social justice campaign in their community.

The Nebraska Coalition has many exciting plans in the works for 2021 as we continue to develop the role of this organization to meet the call of the social justice movement.
